## Rules and Information

### GENERAL SHOW INFORMATION:

1. Show entries are open to anyone. Entry Deadline is Monday, September 14, 2009
2. Judging will be done by NQA certified judges-Maribeth Schmit and Lynne Erbach.
3. Lighthouse Quilters Guild, Inc. will provide security, however, items are entered at your own risk.
4. The entry fee for the first item is \$5.00. The entry fee for items 2 through 8 is \$3.00. There is no entry fee for items 9 and above.
5. You may enter only one (1) item per class.
6. Entry committee/judges reserve the right to reclassify entries as needed.
7. Ribbons will be awarded at the judges' discretion – ribbons may not be awarded in all classes if entered items do not meet judges' criteria.

### ENTRY REQUIREMENTS:

1. Quilts must have three layers (top, batting and back).
2. Item must be entirely made by the entrant unless entered in a "GROUP" class. A GROUP item is one where more than one (1) person has worked on the item at any stage of its construction. GROUP items must list the names of all persons who worked on the item.
3. The *suggested* CLASS for an entered item is determined by the **predominate** method of construction of the item. *Remember, when someone other than the maker quilted the item, the item must be entered in a GROUP class and you must identify the person(s) that quilted the item on the Entry Form.*
4. Items(s) must have been completed within the last five (5) years.
5. All items must be clean and smoke-free.
6. Quilts must have a four-inch rod pocket for hanging. The **TOP** of the rod pocket must be sewn 90" from the bottom of the quilt.
7. Entries must have a label sewn on the lower back (or inside of wearable art) that includes the entry title, entrant's name, address and telephone number. All label information must be **covered for judging** by either basting a piece of muslin over the label or by covering the label with masking tape.
8. Quilts must be in a pillowcase or cloth bag of appropriate size and labeled with your name, address, telephone number. Center the label on the end that opens.

***Any item that does not meet these requirements will not be accepted or shown.  
Entrant will be notified of the disqualification.***

### INELIGIBLE ITEMS:

1. No items entered in a previous Lighthouse Legacies Quilt Show
2. No items NOT completed within the last five (5) years.
3. No 'Cheater Cloth' quilts
4. No Framed Items
5. No Sweatshirts allowed in Class 15 – Apparel

## SUBMITTING ITEMS:

Mailing your Item(s):

- Mailed/shipped items must be packed in a sturdy box and sent to Mary Schaeffer (address above). Items must arrive between September 26 and October 3, 2009.
- Items to be returned must include a RETURN ADDRESS LABEL and will be returned in your original sturdy box. Remember, you must have included a payment of \$20.00 with your Entry Application in order for your item to be returned.

Item Drop-off:

- You will need to allow time for inspection and qualification of your items. You will receive a claim check for each qualified item. This **claim check MUST** be presented at pick-up.
